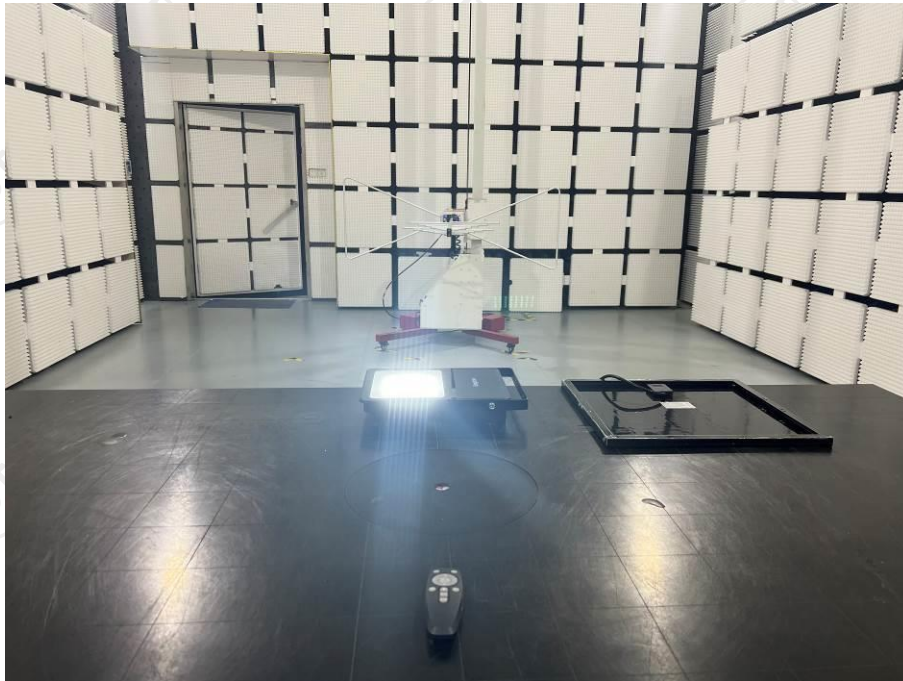

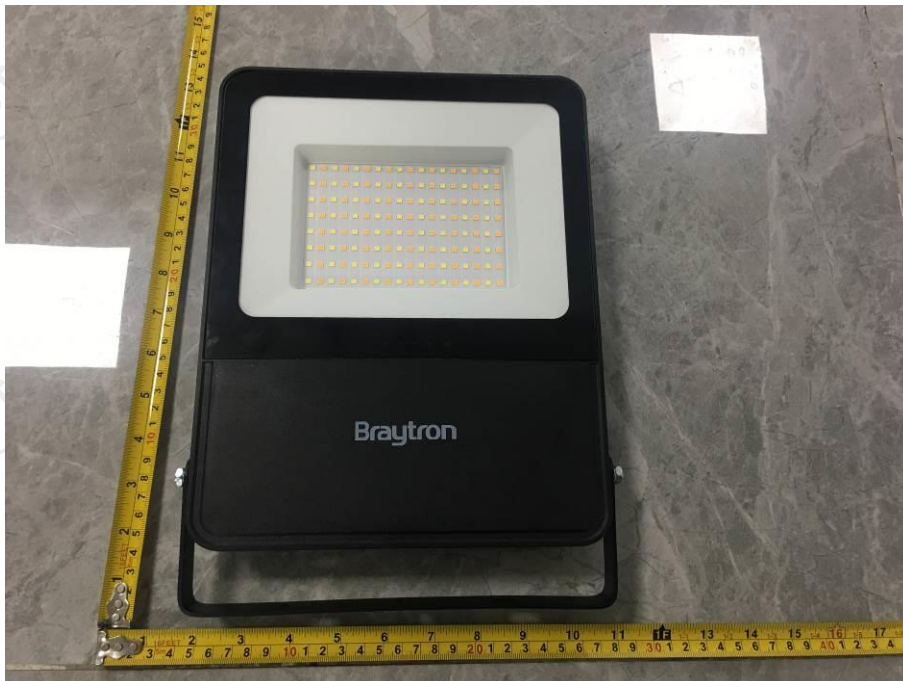
Electrostatic discharge immunity (ESD) test view

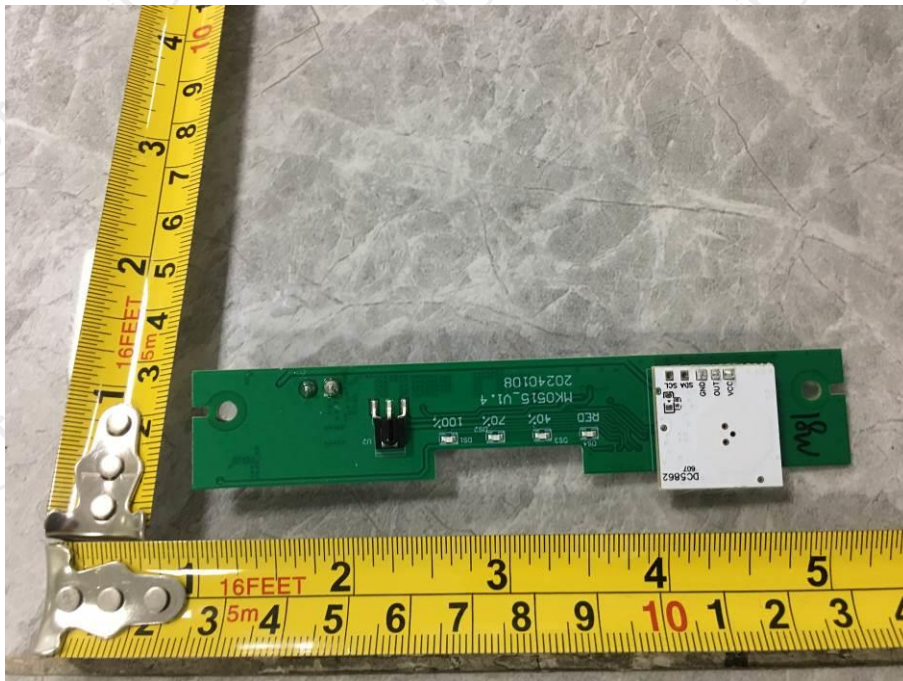
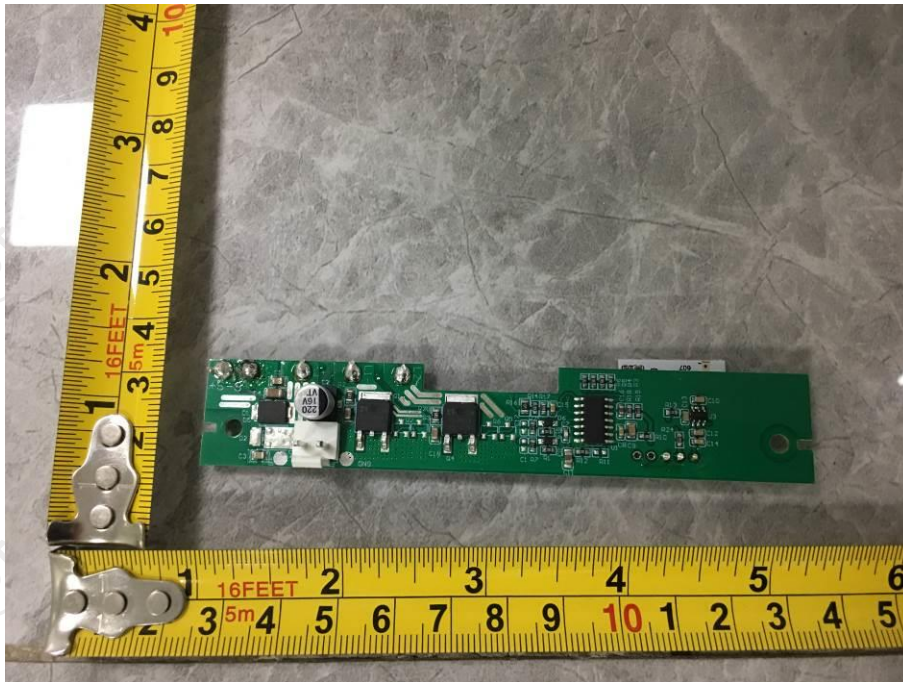
